UCC FILING INFORMATION CHECKLIST/QUESTIONNAIRE

IMPORTANT: Identifying the correct, *legal* name of your customer/debtor (the “Debtor”) is essential to effectively filing your financing statement and all related filings. If you do not obtain and confirm the full, correct, legal name of the Debtor, then your filing will not be afforded full, and in some instances, any, legal protection. As a result, your collateral may not be secured, or your security interest might not be entitled to priority over other secured creditors. Please recall that the customer’s name is not always the same as the name of the “Debtor” for the purpose of filing your financing statement.

Therefore, you should confirm that you have provided Masuda, Funai with the correct, legal name of your Debtor. In addition, the other information required by this Form must also be correct to ensure the proper filing and perfection of your security interest in the collateral.
